AMERICAN IDOL CONTESTANT SUED BY MUSIC DISTRIBUTION COMPANY

ATLANTA – A lawsuit has been filed today by celebrity attorney **Leron Rogers** of Hewitt & Rogers against Larry Platt, known for the “Pants in the Ground” song made famous from his audition on American Idol.

Rogers represents American King Music who has filed suit against Platt, known as “General Larry Platt” pertaining to a music distribution agreement for the song “Pants in the Ground” and for expenses related to producing, writing and recording of Mr. Platt's official recording of the single.

Platt recorded the official, full-length version of “Pants in the Ground” with hip hop star rapper and producer Mims at Mims's studio. American King Music funded the recording session and music distribution of the single on iTunes as well as Mims' production and co-writing of the full-length song.

“My client, American King Music, who funded Mr. Platt's recording session with Mims, would like to compensate Mr. Platt for the sales of the full-length hit song “Pants in the Ground” which we made available on iTunes. However, Mr. Platt and his representatives have failed to take care of Mr. Platt's obligations,” said Rogers who filed the lawsuit in an Atlanta federal court.
